

**PUBLIC NOTICE OF FORMATION OF
OHIO CIRCUIT COURT OF RECORD**

FROM: A group of Ohioans who have been publicly assembling three times monthly since we published our 3 (three) Notices of intent to do so in [A] Prima Facie Newspaper in June, 2020, in order to educate one another about common law and equity and to join together in restoring justice in the Ohio republic by means of a people's court of record having state-wide territorial jurisdiction;

TO. All Ohioans who understand they are not U.S. corporate citizens, who wish to join us in asserting their rights as free people capable of self government under the laws of God, consistently with the 1787 Constitution for the united states of America, help re-establish Constitutional, common law, non-corporate government for the sovereign republic of Ohio at Ohio's first capital, Chillicothe, and who live and intend to continue living on the land mass known as Ohio, a sovereign nation-state and republic since at least March 1, 1803, as described hereinbelow:

Bounded on the east by the Pennsylvania line, on the south by the Ohio River, to the mouth of the Great Miami River, on the west by the line 50 States Metes and Bounds drawn due north from the mouth of the Great Miami aforesaid, and on the north by an east and west line drawn through the southerly extreme of Lake Michigan, running east after intersecting the due north line aforesaid, from the mouth of the Great Miami until it shall intersect Lake Erie or the territorial line, and thence with the same through Lake Erie to the Pennsylvania line aforesaid;

We invite you to join with us as members of the people's Ohio Circuit Court of Record, a non-corporate, Constitutional court of common law and equity, for any who meet the following qualifications:

A. Are at least 18 years of age;

B. Are competent to manage your own affairs;

C. Agree with PL 97-280 enacted by Congress in 1982 affirming that God's law is the law of the land, and that common law, derived from the Holy Bible, Magna Carta, and other time-honored documents, is the closest human approximation to the law of God, our Creator;

D. Recognize that, as one of the people of the Ohio republic, you do not meet any definition of being a U.S. citizen and are willing to demonstrate that understanding by rescinding all voter registration documents by affidavit rebutting any presumptions of consent to the corporate state;

E. Are willing to correct your legal and political status by rebutting all fraudulent presumptions created by our birth certificates, which have been used to monetize our personal information without our knowledge or consent;

F. Are aware that the attorneys purporting to act as agents of the management corporations which have usurped our lawful, Constitutional governments are prohibited from occupying positions of public trust by the original Thirteenth Article to the organic Constitution for the united States of America;

G. Wish to join with other Ohioans to peacefully and consensually assemble as a juror, or other member of our court of record, common law grand jury, and/or associated committees of safety outside the current *de facto* corporate system of statutes, codes, attorneys, and corporations, none of which are recognized in the common law as applying to the people not in contract with those entities.

H. Are willing to take an oath before God to honor the fundamental principle of common law based on the golden rule - to do no harm.

Please be advised that a group of Ohioans who recognize that they are not U.S. citizens have now publicly formed the Ohio Circuit Court of Record, a court of common law and equity. OCCR is also a court of record, in part because it administers the common law. As you are aware, none of the current corporate tribunals calling themselves "courts" meets the definition of being a court of record according to the definition of same provided in Black's Law Dictionary (4th Ed.). Our intentions are and have always been peaceful. We are merely fulfilling a part of the responsibility we have to the people of the Ohio republic

We have no current concern about the measures you may be taking to earn a profit for your employer(s). However, at such point as those activities or others come to our attention as properly framed claims against living men and women and involve common law torts, crimes, contract breaches, or even statutory offenses, we do intend as a body to exercise our sovereign judicial authority under the common law, as our best human expression of the law of the Creator.

As we go through this transition it is our intention to be appropriately transparent and hope we might expect the same from you.
