BE IT KNOWN BY ALL:

- 1) That I am a living flesh and blood woman, known since I can remember by my birth name of Alison Adkins and then changed to Alison Workman. Upon my marriage I became known as Alison Reese. In 2015 I legally changed my name to Alison Reese. I am told and have always believed I was born [REDACTED] in the sovereign republic of Ohio. I am the legitimate daughter of married parents who gave me the name Alison Adkins and then changed to Alison Workman, upon adoption. I am of the Adkins family by birth. I presently live upon the land of the sovereign republic of Ohio where I make my home and am domiciled. I am of lawful age and fully capable of managing my own affairs, my competence has never been questioned. I exercise my right to define myself as one of the people or there posterity referred to in the Preamble to the**

1787 Constitution for the united states of America, and as an Ohioan, meaning a freeman who inhabits and is domiciled in Ohio and from which republic I define my legal and political status. I hereby further define my political and legal character as follows:

- 2) I am not a legal fiction 14th Amendment "person" or "citizen" of the UNITED STATES federal corporation referred to at 28 U.S. Code Sec 3002(15). I am therefore giving Notice that no corporate bylaw called "statute", "rule", "or "code" that applies to legal fiction "persons" or UNITED STATES citizens can apply to me without my consent.
- 3) I am not a legal fiction "citizen", "person", "resident" or employee of the entity variously known as UNITED STATES, united states of America, United States of America, or UNITED STATES CORPORATION COMPANY, whose situs is Washington, in the District of Columbia, nor of its subsidiaries, affiliates, franchises or contractors, whether or not known by other names and legal fictions. I am therefore not subject to Congressional enactments unless I specifically consent to the subject after full and fair disclosure. I do not so consent.
- 4) I am not an estate, chattel property, a transmitting utility, a British or Vatican subject, employee of the STATE OF OHIO or of any other corporation purporting to do business as part of government. I am not a *cestui que vie* trust, a vessel, lost or misplaced cargo, a corporate fiction "person", a corporation, a ship, a dead body, a patient, a client or a slave.
- 5) I am not the all-caps name created after [REDACTED], by any documents created by any agent of STATE OF OHIO, who appropriate my infant identity without the informed consent of either of my parents, thereby perpetrating a fraud against them and me. My parents' signatures on these documents were extracted by means of said fraud and duress exercised against them. Nor am I any variation of the legal fiction all-caps names created by means of the Certificate of Live Birth, including without limitation, ALISON ADKINS, ALLISON ADKINS, ALISON MICHELLE ADKINS, ALLISON MICHELLE ADKINS, ALISON WORKMAN, ALLISON WORKMAN, ALISON MICHELLE WORKMAN, ALLISON MICHELLE WORKMAN, ALISON STRYCZNY, ALLISON STRYCZNY, ALISON MICHELLE STRYCZNY, ALLISON MICHELLE STRYCZNY, ALISON MCLAUGHLIN, ALISON MICHELLE MCLAUGHLIN, ALLISON MCLAUGHLIN, ALLISON MICHELLE MCLAUGHLIN, ALISON REESE, ALISON MICHELLE REESE, ALLISON REESE, ALLISON MICHELLE REESE, or any variation thereof. The creation of any and all assets related to said legal fiction names by men and women unknown to this affiant, impose no liabilities upon me, the living woman. I am entitled to a full accounting from any such men and women who my currently and/or who have in the past, generated income without my informed consent by means of said legal fiction names.
- 6) I reserve my right to choose when to be and when to not be in contract with a corporation. *Merrion v. Jicarilla Apache Tribe*, 455 U.S. 130, 144-148 (1982) (to presume that a sovereign forever waives the right to exercise one of its powers unless it expressly reserves the right to exercise that power in a commercial agreement turns the concept of sovereignty on its head.")
- 7) I also hereby reserve my natural common law right not to be compelled to perform under any contract that I did not enter into knowingly, voluntarily, and intentionally. I do not accept the liability associated with the compelled and pretended "benefit" of any hidden or unrevealed

contract or commercial agreement. As such, the hidden or unrevealed contracts that supposedly create obligations to perform for persons of subject status are inapplicable to me, and are null and void. If I have participated in any of the supposed "benefits" associated with these hidden contracts, I have done so because of threats of violence, under duress, and/or for lack of any other practical alternative. Any such participation does not constitute "acceptance" in contract law, because of the absence of full disclosure of any valid "offer," and voluntary consent without misrepresentation or coercion, under contract law. I, Alison Reese, nee Adkins, known after adoption as Workman, born [REDACTED], being

sworn upon my oath, states as follows:

- 1) That when I placed my signature on voter registration documents, I was never informed of the
ramifications of pledging allegiance to the "res" in trust of the municipal corporation known as
UNITED STATES, doing business as District of Columbia, STATE OF OHIO, Cuyahoga County,
et al., and that said act was without prior notice to me of any forfeiture of God given rights by way
of said act, including, but not limited to forfeiture of rights secured by the Organic Laws of the
United States of America.

- 2) That in placing my signature on voter registration documents I was never informed that said act could forfeit my *de jure* status as one of the people or their posterity and place me under Martial Rule as a citizen, person or resident: or that I could become a "citizen of the UNITED STATES" subject to the jurisdiction thereof, as defined in the 14th Amendment to the Federal Constitution.
