NOTICE TO AGENT IS NOTICE TO PRINCIPAL**

BE IT KNOWN BY ALL:

1. That I am a living flesh and blood woman, known since I can remember by my birth name of Katherine Hine. I am told and have always believed I was born July 15, 1949 on the soil of the Massachusetts republic. I am the legitimate daughter of married parents who gave me the name Katherine Hine and I am of the Hine family. I am domiciled on the land mass known as Ross County, Ohio but have been living on the land mass of a country known as Uruguay. I am of lawful age and fully capable of managing my own affairs. My competence has never been questioned. I exercise my right to define myself as one of the people created by Almighty God, and as an Ohioan, meaning a freeman who remains domiciled in the original Ohio republic, and from which republic I define my legal and political status. I hereby further define my political and legal character as follows:

2. I have previously and by separate instrument clarified my legal and political status, as is publicly recorded in documents posted at [www.occr2021.com](http://www.occr2021.com).

3. I am not a legal fiction 14th Amendment "person" or "citizen" of the UNITED STATES federal corporation, as previously referred to at 28 U.S. Code Sec 3002(10), or of any other corporation masquerading as a country. I am therefore giving Notice that no corporate bylaw,

whether enacted by the corporate STATE OF OHIO, CITY OF CHILLICOTHE, UNITED STATES, their affiliates, subsidiaries and/or parent corporations, and whether labeled as a "statute, "rule", "code", or "Constitution", whether applicable to those agreeing to act as legal fiction "persons" or UNITED STATES citizens, residents, or other statutory labels, can apply to me without my informed consent. I deny having ever granted such consent by signature or by conduct, after having first been provided a full and fair disclosure of all material facts pertaining to the subject of any document to which I have ever affixed my signature, or as to which I have ever engaged in conduct.

4. I am not the all-caps name created either on July 15, 1949 or July 18, 1949 by any documents created by any agents of COMMONWEALTH OF MASSACHUSETTS or STATE OF MASSACHUSETTS, its affiliates, subsidiaries, or parent corporations, who appropriated my infant identity without my consent or the informed consent of either of my parents, thereby perpetrating a fraud against them and me. My parents' signatures on these documents were extracted by means of said fraud and duress exercised against them. Nor am I any variation of the legal fiction all-caps names created by means of the Certificate of Live Birth, including without limitation, KATHERINE HINE, KATHERINE HINE GOOD, KATHERINE CAMPBELL, KATHERINE CAMPBELL ROHRER, KATHERINE HINE ROHRER, KATHERINE ROHRER, KATHERINE H. HINE, KATHERINE SMALLEY or any variation thereof. Any and all assets related to or created under any of said legal fiction names, by men and women unknown to this affiant, impose no liabilities upon me, the living woman. I am entitled to a full accounting from any such men and women who may currently and/or who have in the past, generated income from any perversion of my birth name, without my prior informed consent.

5. I reserve my right to choose when to allow and when to not allow the entity created by the aforementioned perversions of my birth name, to be in contract with a corporation, as has been admitted by Respondents' superiors and predecessors. *Merrion v. Jicarilla Apache Tribe*, 455 U.S. 130, 144-148 (1982).

6. I also hereby reserve my natural, God given, common law rights not to be compelled to perform under any contract that I did not enter into knowingly, voluntarily, intentionally, and with full prior disclosure of all material facts. I do not accept the liability associated with the compelled and pretended "benefit" of any hidden or unrevealed contract or commercial agreement. As such, any hidden or unrevealed contracts that supposedly create obligations to perform for persons of subject status are inapplicable to me, and are null and void. If I have participated in any of the supposed "benefits" associated with these hidden contracts, I have done so because of threats of violence, under duress, and/or for lack of any other practical alternative. Any such participation does not constitute "acceptance" in contract law because of the absence of full disclosure to me of any valid offer and the absence of my voluntary consent without misrepresentation or coercion. Without a valid voluntary offer and acceptance, knowingly entered into by both parties, there is no meeting of the minds and therefore no valid contract. Any supposed "contract" is therefore void *ab initio*.

7. As a free and living woman, living according to the common law and in reverence and obedience to the Lord God Almighty, I hereby repudiate, renounce, rescind, disavow, and revoke my consent, if any ever existed, to the creation of the document entitled "MEMORANDUM OF



TRUST” purporting to create a legal fiction entity known as the “Katherine Hine Revocable Living Trust dated March 12, 2009”.

8. I have never executed any transfers of land or other property into said “Katherine Hine Revocable Living Trust dated March 12, 2009”, by reason of which, according to corporate bylaws of STATE OF OHIO, UNITED STATES, CITY OF CHILLICOTHE, or any other corporate entity masquerading as government, no such “Trust” ever came into existence.


9. I have no knowledge of having ever performed any other act that would support an inference that I intended to be bound by said “Katherine Hine Revocable Living Trust dated March 12, 2009” after that date. Any intention I may have ever had on or after March 12, 2009 to provide future financial benefits to my daughters Rebekah JoAnne Green or Margaret Louise Good, or to my sons, Charles William Rohrer, or John Joseph Rohrer, beyond those I have already conferred to them through the years, no longer exists, for reasons of which I have made them aware.

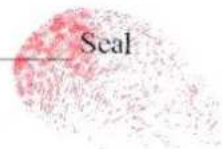
