We, of course, continue to live up to our contractual obligations and expect all our agents, tenants and contractors to do likewise, including by taking reasonable precautions to defend the premises they are occupying. **Response must be by 5 PM at least five (5) days from the date of receipt of this Notification, and be by U.S. certified mail, return receipt requested and by restricted delivery only to:**
